President's MESSAGE —*David F. Gitlin, MD, FAPM*



This past year has been another successful one for the Academy. Our membership continues to flourish as well as increase in size. Our organizational structure has become increasingly functional and productive, with an efficient downsizing of the Council, increased activity from many of our committees, and a stronger communication stream between the two. The 2009 Annual Meeting was the most successful ever. We are actively working on the development of effective relationships with various other organizations that will benefit our membership. Our journal is stronger than ever, with some significant and exciting potential changes coming.

Yet there are still complex and controversial issues facing the Academy and membership that require the attention of both its members and its leaders. Many of these issues led to a robust discussion at the June mid-year Council meeting in Baltimore. I look forward to leading the organization in these discussions as we continue to do our best to chart the most appropriate and successful course for the Academy.

Here are some of the specific issues we have addressed this year.

➲ **Governance:** Following the course set in the 2007 Strategic Planning retreat, we have gradually decreased the size of the Council. This year, we will reach our final goal of 16 Council members, down from 23 in 2007. We believe that this will allow for a more agile and effective leadership structure.

➲ **Clinical Practice:** The Academy provided an outstanding input to the APA leadership request for input on the proposed new DSM-V language and changes, with an extensive and thoughtful response to the changes in the Cognitive Disorders and Somatoform Disorders sections. This was done with an effort to actively include the Academy members in the commentary by soliciting input from the entire membership. More than 60 members provided comments and ideas regarding the proposed changes. The Clinical Practice Committee, under the terrific leadership of **Dr. James Rundell**, also sought out an expert opinion group for input as well, and then crafted these comments into a formal response for the DSM-V Committee.

➲ **Intraorganizational Development:** We have actively pursued the strengthening and/or development of relationships with several other organizations which impact several segments of our membership. These include:

■ **APA:** We have had a series of strategic meetings with APA leadership to address how subspecialties can be more central and valued by the APA. Our leadership participated in a meeting of the Council on Adult Psychiatry that was focused on the importance and future role of subspecialties within the field of psychiatry, and how the subspecialty organizations can interface with APA to maximize their value. This meeting was attended by the incoming APA president, Carol Bernstein, who ex-

pressed her strong support for subspecialties and encouraged increased input from the subspecialty organizations.

In addition, Drs. Bernstein and Alan Schatzberg (APA past president) hosted a separate meeting with the leadership of the five subspecialty organizations. APA was strongly represented by our secretary, **Dr. Linda Worley**. In this meeting, Dr. Bernstein expressed her desire for our active involvement in APA, especially the annual meeting educational activities, and offered a yearly face-to-face meeting with subspecialty and APA leadership. We are hopeful this is the start of improved relationships between the two organizations.

■ **American Association of Emergency Psychiatry (AAEP):** Many of our members have part of their hospital practice in emergency settings. AAEP will present at our meeting, and we are discussing the possibility of AAEP meeting under our umbrella.

■ **EACLPP:** We have worked closely with our European colleagues to develop collaborative practice guidelines and to further increase our interrelationship. A copy of these co-joint guidelines can now be found on our website in the Members' Corner.

■ **American Neuropsychiatric Association (ANPA):** The connections between psychosomatic medicine and neuropsychiatry are self-evident. It will be important to our success and to our membership to further develop this relationship. We have been working with ANPA leadership, particularly **Dr. Paula Trzepacz**, to foster educational cross-activities.

■ **NIH:** Again, it is critical for the success of our subspecialty that we put research in psychosomatic medicine high on our agenda. Our collaborations with NIH, NIMH and other funding centers will be important. **Dr. Steven Epstein** represented APM at a recent collaborative research meeting in an effort to foster increased emphasis on research in psychiatric illness in medical populations.

» **Journal:** *Psychosomatics* has truly flourished in the past few years and continues to have significant impact in the field. The transition to **Dr. Ted Stern** as editor has been extremely successful, and he and the editorial board have moved the effort forward in a number of ways, including shortened time to manuscript decisions and publication. Of equal importance has been the effort over the past year to more directly review our relationship with our publisher, APPI. Despite a positive relationship, we had reached the point the past few years where APM was losing money on the journal and had little control of information and resources. In this past year, we have aggressively pursued these issues with APPI and have simultaneously explored the possibility of taking the journal to a new publisher. I am pleased to say that APPI has responded by improving the royalties to APM retrospectively for 2009 as well as for 2010, such that we are now profitable again. In addition, we have appointed a Presidential Task Force, led by **Dr. Joel Dimsdale**, to create requests for proposals from multiple publishers. This has proceeded with significant interest, and appears to bode extremely well for our journal's future success.

» Subspecialty Issues:

■ **Fellowships:** It has now been six years since subspecialty certification occurred, and ACGME has provided accreditation for psychosomatic medicine fellowships since 2005. Adequate recruitment of fellows is the lifeblood of the subspecialty. While we have more work to do to effectively sustain this effort, the Fellowship Education Subcommittee, under the leadership of **Dr. Cathy Crone**, has worked tirelessly on this issue and helped organize several new initiatives for our fellowship directors and fellows.

"Over 100 posters were accepted and will be available for review (along with hors d'oeuvres and wine) on Thursday evening. The members of the Papers & Posters Subcommittee were particularly pleased with the many contributions from our international colleagues.

"Thirty oral papers, approximately half of those submitted, were selected for presentation on Saturday. These papers touch on a variety of topics of interest to our field including psychiatric aspects of cardiac disease, transplant, hepatitis C,

■ **MOC (Maintenance of Certification):** Several leaders from APM met in June with ABPN leadership to discuss MOC for Psychosomatic Medicine, and to explore whether APM can take the lead in this area. This promises to be an exciting opportunity. I have appointed **Dr. Robert Boland** to head a task force with the goal of developing MOC tools appropriate to PM psychiatrists. Dr. Boland and his team will work closely with the Education Committee and its chair, Dr. Steven Epstein, on this effort, which is of critical importance to all board-certified members.

■ **Annual Meeting:** The 2009 Annual Meeting set a record for abstract submissions and total attendance, and the academic quality of the meeting was remarkable. We are well on our way to another record-breaking meeting for 2010. Abstract submissions were up over 15% from 2009, and our projections suggest we may actually break 600 attendees for the first time ever. Dr. Linda Worley, who is the program chair, has put together a fantastic program thus far. Details can be found in this Newsletter and in subsequent "APM Updates" emails.

■ **Foundation of the Academy of Psychosomatic Medicine:** We successfully launched the new Foundation of the APM (FAPM) at last year's meeting, and have now appointed a board of directors for the Foundation. **Dr. Philip Muskin** has been named as the founding chairperson, and he and the board are beginning the process of development and fund-raising, which should be of great support to many of the efforts of the Academy.

Lastly, let me say that it has been a privilege and honor to have the opportunity to serve as president these past six months. I have enjoyed working with a large number of our members and feel very confident from this experience that the Academy will be a robust and exciting organization for years to come.

CLINICAL PRACTICE COMMITTEE

Consensus Statement Approved

In 2008, the APM and the European Association of Consultation-Liaison Psychiatry and Psychosomatic Medicine (EA CLPP) agreed to cooperate on a consensus statement on "Psychosomatic Medicine and Consultation-Liaison Psychiatry: Scope of Practice, Processes and Competencies." A working group within EA CLPP and APM's Evidence-Based Practice Subcommittee reviewed evidence related to psychosomatic practice and guidelines from different organizations and nations to produce a draft consensus statement. The final consensus document was approved by EA CLPP's board in early 2010 and by the APM Council in June 2010.

The consensus statement, which is posted on the APM website in the Members' Corner, summarizes available evidence supporting the practice of psychosomatic medicine in several domains relevant to inpatient, outpatient, and institutional consultation practice:

- Efficacy of psychiatric consultation in medical-surgical patients and settings
- Scope of psychosomatic medicine practice
- Competencies and skills, knowledge and expertise, and components of a psychosomatic medicine psychiatrist
- Range of psychiatric syndromes and treatment modalities that exist with the scope of practice of psychosomatic medicine

This consensus statement defines evidence supporting the scope, roles, and basic competencies required of a psychosomatic medicine psychiatrist. But these are not the only roles and competencies of a psychosomatic medicine psychiatrist. Different nations have different definitions of the scope, roles, and competencies for the subspecialty. The purpose of the consensus statement is to delineate a set of basic competencies and roles to serve as an internationally recognized base from which national competencies, scope, and roles may be built. It is not a standard to which an individual C-L/PM psychiatrist should be held, but a starting point for each national medical

specialty organization to define this subspecialty or area of special expertise.

PM Advocacy Slide Set Updated

A newly updated PowerPoint set of slides, "Adding Value to Healthcare through Consultation-Liaison Psychiatry," is now available to the APM membership to download free of charge.

The PowerPoint presentation documents the clinical and cost-saving advantages that C-L/PM services provide in general hospital inpatient settings. It is designed to be used by C-L/PM psychiatrists in presentations to department chairs and administrators to advocate for continued support for their programs, or to demonstrate the value of new or expanded programs. It can also be used as an educational tool for fellows, residents, and medical students.

The 65-slide presentation can be shown in its entirety, or portions can be selected to focus on specific issues in a given institution. Earlier 1999 and 1997 versions of the presentation (a.k.a. "Marketing Kit") have been used with success in gaining support for C-L programs in the United States and by our European counterparts.

The new and expanded PowerPoint presentation was created at the initiative of the Business of Psychosomatic Medicine Subcommittee of the Academy's Clinical Practice Committee. The slides are on the APM website in the Members' Corner.

EDUCATION COMMITTEE

Several new items will be posted on the APM website in the near future that will be of interest to psychiatry residents, residency program directors, and potential PM fellows.

Resident Lectures

The Resident Education Subcommittee, chaired by **Dr. Tom Heinrich**, will be posting a series of 13 lectures (PowerPoint presentations) in psychosomatic medicine tailored to the educational level of a junior resident in psychiatry. The topics are varied and meant to cover some of the most salient and important issues in psychosomatic medicine that we encourage psychiatry residents to receive. The complete lectures will be posted in the Members' Corner of our website and will be free for downloading by APM members. The first five slides for each lecture will be posted for the public in the "Career" section of the site. The intent is for residency program directors to include these lectures in their programs.

Common Fellowship Application

The Fellowship Education Subcommittee, chaired by **Dr. Catherine Crone**, will be posting a "Common App" (common application) for fellowship candidates to fill out and submit to their programs of choice. The application was developed using input from a number of program directors who are APM members. Those programs which will accept the common application will be so indicated on APM's online Fellowship Directory (which is in the "Career" section of the website).

AIDS PSYCHIATRY SIG

The APM AIDS Psychiatry SIG (AP SIG) continues to grow from 32 members in 2004 to nearly 250 national and international members as of July 2010.

SIG members **Drs. Batista, Cozza, Goforth, Lux, Khalife, Soffer, and I** co-authored the *Handbook of AIDS Psychiatry* published on April 12, 2010. The book is the companion to the *Textbook of AIDS Psychiatry* (with 29 AP SIG contributors) that was published in 2008.

During this academic year, in addition to presentations and publications, SIG members participated in a series of AIDS psychiatric treatment consensus surveys to address significant issues that were not addressed in the first membership survey in spring 2008. **Drs. Angelino,**



Batista, Cournos, Ferrando, and Grimaldi will be working with us on our next project relating to the recognition and treatment of HIV-associated neurocognitive disorders. The results of the 2008 survey will be published in a forthcoming issue of *Psychosomatics* in an article written by SIG members **Drs. Freudenberg, Goforth, Cozza, and Cohen**. The article is entitled "Psychiatric Treatment of Persons with HIV/AIDS: An HIV-Psychiatry Consensus Survey of Current Practices."

I am pleased to report that our symposium was accepted for presentation at the 2010 Annual Meeting on Friday, November 12 from 9:30–11:30am. This symposium, *Educating Clinicians about HIV-Associated Dementia*, is presented by SIG members and covers significant topics:

- **Risk Factors for HIV-Associated Neuropsychological Disorders (HAND)**—Jordi Blanch, MD, Clinical Institute of Neurosciences, Hospital Clinic de Barcelona, Spain
- **Early Recognition of HIV-Associated Dementia: Differential Diagnosis**—Adriana Carvalhal, MD, MSc, PhD, McMaster University School of Medicine, Ontario, Canada
- **Early Recognition of HAD: Complexities of Assessment and Screening**—Stephen J. Ferrando, MD, FAPM, Weill Cornell Medical College
- **Developing Screening Tools for HAD and Assessing Current Practices**—Andrew Angelino, MD, FAPM, Johns Hopkins University; and John Grimaldi, MD, Harvard Medical School

However, we encourage each presenter to send us their PowerPoint file, and bibliography if it exists separately, for posting on the website as PDF files so that registrants may print them at home and bring them to the meeting. To ensure the materials are posted a week before the meeting to give registrants time to print them, we suggest you send your slides and bibliography to webmaster@apm.org by October 27, although we will accept and post them as they are received, even after the meeting. The slides will reside in a password-protected area of the site; each registrant will be given the login. In January 2011, the slides will be moved to the Members' Corner for access by APM members only.

Audio/Visual Needs. Each meeting room will be set up with a laptop (no mouse), an LCD projector, and a microphone. If you need additional A/V equipment, contact Academy Coordinator Kristen Flemming (kflemming@apm.org) **before October 15, 2010.**

Frequently Asked Questions

ABOUT REGISTRATION

Got a question about registering for the meeting? Please review these FAQs to see if it's already been answered. If you still have questions, please contact the Academy office at 301-718-6520 or apm@apm.org.

Q: I am a member of APM and I'm the main speaker at a symposium. Is my registration fee waived for the meeting?

A: No. APM members pay the member rate, whether or not they are presenting a workshop, symposium, oral paper, or poster.

Q: I am not a member of APM but my abstract for an oral paper has been accepted. The registration form says non-member presenters "listed in the program" can register at the member rate. How can I tell if I will be listed in the program?

A: When you submitted your abstract, the person you designated as the presenter of your oral or poster paper may register at the member rate. If you are a co-author and will not be presenting (even though you may be present), you must register at the non-member rate if you are a non-member. If there are any changes as to who will be the presenter, notify the Academy office immediately so appropriate changes can be made to the Final Program.

Q: I am able to attend only one day of the annual meeting. Can I register for just one day and not the whole conference?

A: You may register for the Wednesday pre-conference courses without registering for the meeting, but there is no per-day rate for the meeting itself. You must pay the full fee for the three-day meeting even though you attend only one of the days.

Q: What "proof of status" do you need for a student/resident/fellow so that I can register at the student rate?

A: Any of the following are acceptable as proof: a copy of your student ID card at your educational institution; a letter from your program director confirming your participation in the program; a letter from the school's registrar confirming your current enrollment.

If you register online for the meeting, upload an electronic copy of the proof. If you register by mail or fax, send hardcopy of the proof.

Q: My mother is very ill and her doctors have suggested she get her affairs in order. I really want to go to the annual meeting and I want the \$100 discount for early birds. Do you have an exception policy for the no-refund-after-November 1 rule in case my mom takes a turn for the worse right before the meeting and I feel compelled to stay close to her, or even to make funeral arrangements?

A: Yes, we do consider exceptions to the rule. If you yourself are too ill to attend and you submit a note from your primary physician, or in extenuating circumstances such as the death of a family member, your case will be reviewed for a full or partial refund.

Q: When I register for the meeting, just how many of those extra events do I have to buy tickets for? Are they all included in my registration fee?

A: On the registration form, event tickets are listed in two separate groups for a reason. The first group, "Guest Event Tickets," need be purchased ONLY FOR GUESTS as these events are included in the price of registration. The second group, "Optional Event Tickets," must be purchased for both meeting registrants and guests who wish to attend the respective event.

Q: I won't know until the last minute if my spouse can join me at the meeting. Can I wait to purchase guest tickets for the luncheons and receptions until I check in for the meeting?

A: Yes, but plan on spending extra time at the Registration Desk for processing the extra tickets. In any case, tickets for any event must be purchased no later than 5:00pm the day before the event so that the hotel can pre-

pare enough food for everyone. The exception is the tennis tournament: tickets must be purchased two weeks in advance.

Q: Is lunch included with the half-day skills courses on Wednesday?

A: No. Lunch is included with only the full-day *Updates in Psychosomatic Medicine* course. But skills-course registrants may purchase the Wednesday buffet lunch for \$25 on the registration form.

Q: Can you assure me that my special dietary needs will be honored at the food functions?


A: The hotel can accommodate special dietary needs if notified well in advance, which means you must notify the Academy office no later than October 15 (register before that date and check the "special dietary needs" box). The Academy will provide the hotel with the names of those who requested special diets so that waiters can serve the special meals to the proper people. It should be noted that meeting etiquette calls for attendees to not claim specially prepared meals that they have not requested in advance.

Q: Do I need to select the workshops and symposia I want to attend in advance?

A: No. Meeting rooms are filled in a first-come, first-to-get-a-seat fashion.

Q: Will I still be able to register in advance after October 14?

A: Yes, at the on-site price. Online registration will be available until October 29. If you register after October 14 by mail or fax, be sure to bring a copy of your completed registration form to the meeting in case it was received too late to be processed completely. Also, expect a delay at the Registration Desk because your badge and other meeting materials may not be ready for you.


