President's MESSAGE — Catherine C. Crone, MD, FAPM



Greetings and Happy New Year! While the sun and warmth of Fort Lauderdale may now seem like a distant memory as we bundle up against the cold, many of our members attended the Academy's 2014 Annual Meeting and benefited from a terrific program. Led by **Dr. Linda Worley**, 2014 APM president, and program chair **Dr. J. Michael Bostwick**, the meeting set a new record of nearly 860 attendees. The meeting program offered a breadth of education on topics that included, but were not limited to, perinatal psychiatry, toxidromes, medical marijuana, bedside psychotherapy, ventricular assist devices, autonomy versus medical futility, depression following TBI and spinal cord injury, as well as early career psychiatry. A number of excellent presentations were organized by our SIGs, some even involved collaborative efforts across SIGs, such as ethics and palliative care as well as transplant and cardiovascular psychiatry. With many of us facing the ABPN PM recertification exam this spring or PM Boards in fall 2015, there was also a comprehensive and information-packed *Updates in Psychosomatic Medicine* course to help us with our test preparation efforts. For those who were unable to attend the course or the annual meeting, it is available for purchase and viewing through our website's Live Learning Center. Our meeting was also preceded with the opportunity to take a pre-test to allow us to gather those important MOC credits. Many thanks are owed to the members of the Annual Meeting Committee, Maintenance of Certification Subcommittee, Fellowship and Awards Subcommittee, SIGs, and Research & Evidence-Based Practice Committee whose hard work led to the success of our Fort Lauderdale meeting. Please forgive me if I did not list all the committees and subcommittees that contributed, but please know your efforts are crucial to our members.

We are currently in the process of planning for the 2015 Annual Meeting, which will be held in New Orleans, Louisiana, at the Hilton New Orleans Riverside Hotel, November 11-14. Under the direction of **Dr. Philip Bialer** as program chair, the theme of this upcoming meeting is **"The Art and Science of Communication."** The chosen theme is meant to focus on the special skills that consultation-liaison psychiatrists offer, whether referring to direct communication with patients, families, and other health care providers, educating others about patient-physician communication, or research into communication skills and collaborative care. In keeping with the theme, we are in the midst of arranging for our plenary speakers, who will include Dr. Rita Charon, Director of the Program in Narrative Medicine at Columbia University College of Physicians and Surgeons, and Dr. Grayson Norquist, Chair of the Patient-Centered Outcomes Board of Governors, an organization focused on addressing health care disparities and evidence-based information needs for patients, caregivers, and clinicians. Announcements about our other plenary speakers will be forthcoming.

ries and how these stories serve to educate us. Our patients are also our teachers, and the patient narrator fits in very well with the theme for our upcoming meeting, as you will see below. Dr. Bostwick, the program chair, participated by sharing a story of one of his own patients. In addition, we were treated to stimulating thought-provoking lectures by APM Research Award winner, **Dr. Jesse Fann** and Hackett Award winner, **Dr. Lewis Cohen**. Current American Psychiatric Association President **Dr. Paul Summergrad**, also participated and spoke of the important role psychosomatic medicine plays in the shift towards integrated care.

We are now well into planning the 2015 Annual Meeting which will take place in New Orleans, November 11–14. President Dr. Cathy Crone has chosen the theme "**The Art and Science of Communication in Psychosomatic Medicine.**" Communication encompasses broad areas including how we communicate with our patients, how we communicate with each other, and how we communicate with the public. We are currently finalizing the roster of plenary speakers who have special expertise in these various areas of communication that

range from patient outcomes research, to bedside psychotherapy, to the patient narrative.

This past year we also introduced a meeting app for mobile devices which proved to be highly successful. Participants were able to plan an individualized schedule, download presentations, and evaluate the meeting. Internal feedback about the app has been extremely positive and we will continue to refine and streamline our materials to make the meeting as beneficial as possible for all who attend.

Of course, much of the success of the annual meeting depends upon the hard-working members of the program committee. The Pre-Conference Courses Subcommittee is co-chaired by **Drs. Maryland Pao** and **Lisa Rosenthal**. Although the next initial certification exam for Psychosomatic Medicine will not take place until 2017, an MOC recertification exam will again be offered in 2016. We are, therefore, considering a full-day updates course similar in format to the very popular updates courses at last year's meeting.

Drs. Sandra Rackley and **Christopher Sola** are co-chairs of what we have traditionally called the Work-

shops & Symposia Subcommittee. But there's a twist in the approach for 2015. Over the years, there has been less distinction between these two formats, as most sessions have been scheduled for an equal amount of time, and the level of interactivity of workshops has varied. So for 2015 we're dropping these sometimes limiting labels and describing our educational offerings as "general sessions." As we continue to discuss and refine this issue, these sessions remain an integral part of our program, and the subcommittee will be focused on choosing the submissions that will provide the highest caliber educational experience for our attendees, regardless of format.

Drs. Jon Levenson and Christina Wichman are heading up the Oral Papers & Posters Subcommittee. This is yet another part of the program that has continued to develop and grow. The poster session in particular allows for an incredible amount of give and take among students, residents, fellows, and junior and senior faculty. This event has become one of the most popular of the annual meeting as it segues into the Thursday evening Welcome Reception.

We are also paying special attention to our trainees and early career

psychiatrists with a subcommittee co-chaired by **Drs. Kristin Somers and John Taylor**, who are making ambitious plans to develop our networking opportunities for this growing cohort of annual meeting attendees.

Finally, did I mention that this meeting will be taking place in New Orleans? *Of course I did!* The Hilton Riverside will serve as our host hotel and we have recently expanded our block of rooms with the hopes that we can accommodate everyone who is attending. There will also be additional lodging available in close proximity if needed. The hotel is next to the Riverwalk, a short walk to the French Quarter and also close to the Warehouse District. Our Local Arrangements Subcommittee, co-chaired by **Drs. Anne Gross and Laura Kent**, is planning some fabulous activities for all of us given the plethora of great restaurants, great jazz, and great fun to be had in New Orleans. Beignets and café au lait, anyone?

Start working on your submissions. There is a firm deadline of April 1 for all submissions, with no extensions. I expect this to be a meeting we will long remember as one of the best!

- Evidence-informed policy development

- APA governance

APM FELLOWSHIP ELIGIBILITY CRITERIA AMENDED

Responding to recommendations from the Fellowship & Awards Subcommittee, the APM Council has approved updates to the Fellowship eligibility criteria. The main changes for 2015 candidates are:

1. Must have completed a PM/C-L fellowship a minimum of six (6) years prior and/or have received certification in Psychosomatic Medicine or have completed a dual residency. Candidates may receive exceptions depending on individual circumstances.
2. Have attended at least three APM Annual Meetings in the last five years prior to application.
3. Has been or is currently an active contributor to the Academy in three of the past five years through one or more of the following volunteer activities: 1) membership on an Academy committee, subcommittee, or taskforce; 2) service as chair, co-chair, or vice chair of an Academy special interest group; 3) presented at an Academy annual meeting as (a) a moderator, speaker, or discussant for a pre-conference course or general session; or (b) a lead presenting author for a poster or an oral paper session.
4. Be sponsored by two Academy Fellows who must submit a letter of recommendation on the candidate's behalf to the APM Fellowship & Awards Subcommittee. Letters of reference should address the candidate's contribution to the Academy and/or field of psychosomatic medicine in two or more of the following areas:
 - Clinical administration service in psychosomatic medicine
 - Education in psychosomatic medicine
 - Scholarship in psychosomatic medicine, exemplified by publications

- Promotion of psychosomatic medicine outside of participation in the Academy (with examples)

Specifically, the updates are intended to recognize candidates for Fellowship that have made demonstrable contributions to the Academy, as much as for contributions to the field of psychosomatic medicine.

The changes will be effective for all candidate applications this year. The website was updated with the new eligibility criteria in late February and was accompanied by the introduction of an online application process. Due to the volume of submissions, the Academy will no longer accept applications by fax, email, or paper.

A further modification to the criteria is scheduled for 2016, when the time-out-of-training eligibility criterion will be increased from three to six years. A bylaws change, scheduled for November, is needed before this criterion can be modified.

FELLOWSHIP EDUCATION SUBCOMMITTEE NEWS

The Fellowship Education Subcommittee continues to work in assisting program directors to develop and run successful psychosomatic medicine fellowship programs. We have an outstanding committee this year and each of our members is active in contributing to our work.

Directors' Forum

At our Directors' Forum at the APM Annual Meeting in Fort Lauderdale, Paul Desan, MD, PhD, presented an update on recruitment and the NRMP Match process. Over the past 10 years, there has been a steady rise in the number of PM fellows and also a steady rise in the number of PM fellowships. By contrast, over the same time period, the subspecialties of Forensic and Addiction Psychiatry have been stable, while Geriatric Psychiatry is declining in positions and fellows. Dr. Desan also presented results of a survey of current fellows, the first group to apply through the Match; responses were strongly in favor of the Match process.

Robert Boland, MD, FAPM, chair of the Psychosomatic Medicine Milestones Workgroup, also presented at the Directors' Forum. Beginning July 2015, all of our fellowships will be required by the ACGME to use the Milestones. Dr. Boland introduced the Milestones and the process for using them in fellowship programs.

For the future, it is our hope to use the Directors' Forum to provide updates on new developments in fellowship education, including new requirements. We hope that the forum will serve to represent the opinions and interests of our program directors, and to help facilitate needed changes in the fellowships as a coherent group.

Nuts & Bolts Workshop

The Fellowship Education Subcommittee presented a workshop at the recent annual meeting. The workshop covered the full set of ACGME requirements for PM fellowships. The subcommittee will plan to continue the tradition of developing a "Nuts and Bolts" course for program directors at our annual meeting. Our workshop always welcomes program directors. We hope that it will serve as a resource for keeping us informed and up-to-date, and for assisting with the confusing and ever-changing mandates from the ACGME.

Assessment Tools


The work of the Fellowship Education Subcommittee this year will include the development of assessment forms for PM program directors. We are in the process of creating several standardized evaluation forms that can be used across all PM fellowship programs that will reflect the format of the PM Milestones.

NRMP Match

As you know, the Match occurred on January 7th. Our match results remind us that recruitment of fellows continues to be of highest

importance to our field. With 52 enrolled programs, there were 93 positions in the Match and 64 of these positions were filled, a fill rate of 69%, which is the same as last year. Increasing resident interest and fellowship recruitment will be a priority of our committee this year. Overall, the match process went smoothly. We are grateful for all of your work in adapting to the process, as this is an essential part of our success as a subspecialty.

Certification / Recertification

As a reminder, the PM certification exam is offered October 13-16, 2015. Deadline for registration is April 1, 2015, and the late deadline is June 1, 2015. Note that the fee for late application is \$500.

For individuals recertifying, the next Maintenance of Certification (MOC) is offered April 13-17, 2015. The next MOC exam will be April 18-22, 2016, with application deadline November 3, 2015; the late deadline is December 1, 2015, with a late application fee of \$500.

Some tips: Written exams administered in 2015-16 will use classifications and diagnostic criteria that have **not** changed from DSM-IV-TR. Diagnoses from DSM-IV-TR that are obsolete will **not** be tested. Diagnoses that are new to DSM-5 (those that were not mentioned at all in DSM-IV-TR) will **not** be tested. However, diagnoses that are exactly or substantially the same in both DSM editions **will** be tested. This includes those that have a name change only, those that have been expanded into more than one new diagnosis, and those that have been subsumed or combined into a new diagnosis. For these diagnoses, **both the DSM-IV-TR and the DSM-5 diagnosis will be included** in the test items.

Remember that the MOC process requires a significant amount of self-assessment CME credit. Be sure to take the self-assessment MOC exams before the annual meeting! Eight hours of credit are provided. If you do not use this important free service to meeting attendees, you may need to pay to obtain the required hours of self-assessment credit.

AWARDS

HACKETT AWARD

The Eleanor and Thomas P. Hackett Memorial Award is the Academy's highest honor, given in recognition of outstanding achievement across an entire career in psychosomatic medicine in training, research, clinical practice, and leadership. **Lewis Cohen, MD, FAPM**, received the 2014 award, speaking on "Fatal Decisions," which consisted of readings from a recent piece he had written about Sigmund Freud's medical care, accompanied with selections from his current book project about assisted dying.

In his lecture, Dr. Cohen noted that it is now widely considered legal and ethical in the U.S. to withhold and withdraw life-support treatments, provide palliative sedation and analgesics, agree with voluntary cessation of eating and drinking, and facilitate the use of hospice services (which precede over one million deaths annually). His presentation sought to challenge the audience to also think about the more controversial and less accepted practices of "aid in dying," "death with dignity," "self-deliverance," or what is most commonly known as "assisted suicide" or "euthanasia."

Dr. Cohen's abstract described how "One of the great privileges that come with wearing

a white coat to work is that we frequently participate in the dramas surrounding death and dying. One of our great misfortunes is that people turn to us during these momentous situations for counsel and advice. No one taught me what to say or to do, and no one ever prepared me that the entire field of medicine was in the process of undergoing a cataclysmic philosophical shift in its approach to people's right to shape their terminal care and their deaths. I am still trying to figure out how to respond in these situations.

"My hypothesis is that when people become severely ill they not only want to suffer minimally and to function maximally, but

that as the end approaches, many—but not all—want greater control over the timing and manner of death. There is a spectrum of techniques that we can now offer in order to hasten the dying process."

It would be an understatement to say Dr. Cohen's presentation was very well-received by attendees; it ended with a standing ovation.

Dr. Cohen is the principal investigator of a new PCORI (Patient-Centered Outcomes Research Institute) project improving end-of-life communication among dialysis patients residing in New England and New Mexico. His academic career has been focused on integrating nephrology, palliative medicine, and psychiatric practice in the care of patients with renal failure. He is the author of *No Good Deed* (Harper Collins, 2010) and is writing a new nonfiction book for the general public about the American assisted dying (physician-assisted suicide) movement. He is a professor at Tufts University School of Medicine and has been a consultation psychiatrist at Baystate Medical Center in Springfield, MA, for the past three decades.

Dr. Cohen was introduced by his wife, Joan Berzoff, MD, professor at Smith College School for Social Work, Smith College, Northampton, MA.

AWARD OF SPECIAL RECOGNITION

The Award of Special Recognition is conferred on individuals for outstanding service to the field of psychosomatic medicine on a local or national level.

Philip Bialer, MD, FAPM, received the 2014 award in recognition of his outstanding—and very successful—efforts in organizing Psychosomatic Medicine's participation in the NRMP Match program.

Dr. Bialer is the Director of Training for the Communication Skills and Research Lab at Memorial Sloan Kettering Cancer Center in New York City. He is also the Associate Training Director for the Psychosomatic Medicine Fellowship at MSKCC. Dr. Bialer serves on the APM Council as Chair of the 2015 Annual Meeting Program Committee and, until recently, was chair of APM's Education Committee.

RESEARCH AWARD


The APM Research Award is given to honor the accomplishments and stature of a currently active researcher in the field of psychosomatic medicine. This year's award was presented to **Jesse Fann, MD, FAPM**, who spoke on "Nervous Breakdown: Depression Following Traumatic Brain and Spinal Cord Injury."

Dr. Fann is a professor in the Department of Psychiatry and Behavioral Sciences, and adjunct professor in the Departments of Rehabilitation Medicine and Epidemiology, at the University of Washington. He is also director of Psychiatry and Psychology Services at the Fred Hutchinson Cancer Research Center/Seattle Cancer Care Alliance. He

received his B.S. in Electrical Engineering from Stanford University, his M.D. from Northwestern University, and his M.P.H. from the University of Washington. Dr. Fann is a Fellow of the APM, past recipient of the Dlin/Fischer Award, and an inaugural recipient of the Academy's Webb Fellowship.

Over the past 20 years, Dr. Fann has conducted studies examining the epidemiology and treatment of psychiatric disorders, particularly depression, following traumatic brain injury, spinal cord injury, and cancer. He has been principal investigator on studies funded by the NIH, the Department of Education, the CDC, and the American Cancer Society. Dr. Fann has authored over 80 peer-reviewed scientific articles and has served on numer-

ous national editorial and advisory boards, including the Department of Defense's Psychological Health Advisory Board.

DLIN/FISCHER AWARD

The Dlin/Fischer Clinical Research Award is presented for significant achievement in clinical research and the best paper submitted for presentation at the annual meeting. The award is named for Barney "Ben" Dlin, MD, FAPM, president of APM 1983-84, and H. Keith Fischer, MD, FAPM, president 1975-76.

José Maldonado, MD, FAPM, received the 2014 award and spoke on "Prospective Validation Study of the Prediction of Alcohol Withdrawal Severity Scale (PAWSS) of a New Scale for the Prediction of Moderate to Severe Alcohol Withdrawal Syndrome."

This was Dr. Maldonado's second time winning the Dlin/Fischer award; he was also a recipient in 2004.

Dr. Maldonado is an Associate Professor of Psychiatry, Medicine, Surgery, Emergency Medicine, and Law at Stanford University in California. He has been the Chief of Psychosomatic Medicine at Stanford since 1996; a member of the Academy of Psychosomatic Medicine since 1991 and an APM Fellow since 1996; a 2009 recipient of APM's Dorfman Journal Award for Best Article for Original Research; and the Herbert Spiegel Award for Hypnosis Research from the Department of Psychiatry at Columbia University and New York State Psychiatric Institute. His research interests include: the neurobiology and management of delirium; psychosocial aspects of solid organ and composite tissue transplantation; novel methods for the diagnosis, prophylaxis and treatment of alcohol withdrawal syndromes; and the medical use of hypnosis.

DON LIPSITT AWARD For Achievement in Integrated and Collaborative Care





Topics on the table are eating disorders, somatoform/complicated medical illness in women, and perimenopause/menopause.

A subgroup headed by Drs. Laura McLafferty and Linda Worley is preparing a publication on the topic of substance abuse during pregnancy. In addition, the SIG is also exploring advocacy opportunities for women. Lastly, the SIG is establishing an APM listserv for improved communication and sharing content. Please be in touch (n-dresner@northwestern.edu) if you wish to be included in our listserv, and as always, with feedback, comments, or questions.

In the Czech Republic: **NEW PROFESSIONAL SOCIETY FOR PSYCHOSOMATIC MEDICINE**

After a delay of over twenty years, Czech medicine has joined fellow developed European countries by accepting psychosomatic medicine among its acknowledged medical fields.

At the end of April 2014, the Czech Medical Society of Jan Evangelista Purkyně (ČLS JEP) founded the new Society of Psychosomatic Medicine. The ČLS JEP is the largest physician association of the Czech Republic with currently 34,000 doctors and other health care professionals in 120 societies. The over 200 founding members of the new PM society are doctors from somatic disciplines, psychiatrists, psychologists, and physiotherapists. The goal is to accelerate the development of psychosomatic medicine in the Czech Republic and to integrate the psychosomatic approach in the Czech health care system.

Currently, the new psychosomatic society is working with the Accreditation Commission of the Ministry for Health on the content and concept of the discipline. A network of psychosomatic departments is being created and a system of specialized education for physicians in the field of psychosomatics is being prepared. The doctors should become the first link in a

chain that can help patients with complicated psychosomatic diseases.

Vladislav Chvála, MD, was elected chairman of the new society. He presented this statement in regards to the position of psychosomatic medicine in the overall health care system: "In the last few decades, the opinion was favored that the improvement of laboratory equipment and instrumentation, including a significant expansion of pharmacology, will manage to solve most of the diseases. The World Health Organization (WHO) was proudly claiming the bio-psycho-social approach to health and disease, but, unfortunately, the reality was a massive growth of biological medicine. Later it turned out that this trend leads to a sharp increase of the costs for health care. Yet, we see more and more patients with chronic non-infectious and non-malignant diseases. According to studies, such patients make up around 40% of all patients. Psychological and social factors contribute substantially to the genesis and persistence of their diseases. Psychosomatic medicine provides the missing link in the treatment system and may even help to save a considerable amount of money for the health care system."

The EAPM is an interdisciplinary and multi-professional scientific association that includes researchers and clinicians with different professional backgrounds working in the field of Psychosomatic Medicine and C-L Psychiatry. EAPM was founded in 2012 through the merger of two associations, the European Association of C-L Psychiatry and Psychosomatics (EACLPP) and the European Network of Psychosomatic Medicine. This is reflected in the EAPM membership and the topics of the working groups, special interest groups, and annual conferences. The annual meetings cover neurobiological as well as psychological and psychotherapeutic topics.

We congratulate the award winners. Both of them will give an award lecture at the upcoming scientific EAPM conference in Nuremberg, Germany, in July.


Joint activities of APM and EAPM
